

**Instructions for preparing manuscripts to be published in
RMBS-ISA Conference Proceedings for RMBS 2010**

Pending abstract acceptance, you will be invited to submit your paper, and registration information to the RMBS Website, by **Friday, December 18th, 2009**. Please carefully follow these instructions:

- (1) Submit your finished camera ready manuscript (PDF format ONLY) through the RMBS website:

- (2) **Mail or fax** a completed registration form, (including check or credit card payment), and a completed "ISA copyright assignment" form for each paper to the program chair. Any applicable extra page charges must be included with the payment (see "length" below)

Follow the formatting instructions below. Papers that do not comply may not be printed in the proceedings:

Copies: Submit an electronic copy of the abstract in PDF format by **November 6, 2009**. Pending abstract acceptance, you will be invited to submit a full-length manuscript in PDF format by **December 18, 2009**.

Length: Papers are limited to six pages **MAXIMUM** including figures, tables, and references. Each page over the six-page limit will entail an additional charge of \$100 per page payable with the manuscript submission. If the extra page charge is not submitted with the manuscript, the paper will not be included in the proceedings.

Page Numbering: **Do not include the page numbers in the file.**

Style: Follow the RMBS template format downloadable from the RMBS web site, or the IEEE single column Transactions style. Use separate sections such as; Abstract, Introduction, Materials & Methods, Results, Discussion, Conclusions, Acknowledgments, and References.

Page Size: Use 216 x 279 mm (8.5" x 11").

Margins: Leave 28.7 mm (1-1/8") margins at the top and bottom and 19 mm (3/4") on the left and right sides.

Layout: Center the title, authors' names, affiliations (with full postal addresses) spanning the entire page. Use a style similar to that shown on the sample page.

Type Font, Style and Size: Use Times New Roman Regular (the font on this text) or a **close equivalent**, 18 point bold capital letters for the title, 14 point bold capital letters for section titles, and 12 point characters for the text. **DO NOT USE FONT SIZES SMALLER THAN 8 POINTS.**

Font Embedding: to ensure all your text, equations and figures are printed as you see them on your computer monitor, **YOU MUST EMBED ALL THE FONTS IN YOUR DOCUMENT FILE!** To do so, specific procedures depend on the program you are using:

- If you are submitting the manuscript as a PDF and you are creating it by printing to the virtual PDF printer (distiller, Adobe PDF, Adobe PDFWriter or similar”, when the print interface appears, select Preferences (or Properties), and then make sure that “Do not send font to ...” is NOT checked.
- If you are using other methods to create the PDF, you should be able to find similar options. When in doubt, refer to the documentation of your application or do an internet search to find out how to accomplish the embedding of the fonts.
- To verify your PDF file is correct, open it with Acrobat Reader, then make sure that the item “Use Local Fonts” item in the “View” or in the “Advanced” menu (depending on the version of Acrobat you are using) is unchecked. When doing so the document will be shown as it appears on a computer that does not have your fonts installed. Scroll through the entire document. If there are any fonts needed which cannot be found, you will receive a warning message. Pay special attention to parts of the text with special characters. Check to see that these characters appear correctly when "Use Local Fonts" is off.

Abstract: Include appropriate keywords at the end of the abstract to allow retrieval by electronic media software.

Keywords: Include up to 10 keywords at the end of the abstract to allow retrieval by electronic media software.

References: Number references in their text order using square brackets. Place citations at the end of the text using IEEE Transactions format. Do not include any references with the citation “to be published” or “submitted.” If the citation is a “personal communication,” include the source’s name, affiliation, and full postal address.

Figures: Paste figures where needed, if necessary, spanning the entire width of the page within the allowable margins. Number and provide a caption for each figure. Do not use characters smaller than 8 point. Do not submit poor quality scans or color images. **The papers will be printed black and white only, so do not include color images and make sure all your figures and graphs are readable when converted to grayscale.** Also, if you are submitting your paper in Microsoft Word format, please make sure that all the figures are embedded in the file and are not defined as links to files external to the main document.

Publishing your paper is a team effort involving RMBS volunteers, ISA staff, professional publishers, and most important—you, the author. Please comply with these guidelines. This will ensure a quality, professional RMBS-ISA publication. Thank you.
